To All Prospective Bidders:

For the benefit of all prospective Bidders and to avoid possible confusion in bidding, we wish to clarify the bid document as follows:

Bid due date was August 5, 1999. **The revised bid due date is August 12, 1999 at 10:30 a.m.**

In the revised bid document of 7-16-99 please make the following corrections:

Page 5, of 107, Fee Schedule Last Line Item; **DELETE** "Aerification of Turf four times per year". It is incorrect and duplicates the first line item.

Pages 10, 18, 26, 34, and 42, of 107; Fee Schedule Last Line Item; **DELETE** "Turf Fertilization four times per year". There is no turf at Jones Hall.

Pages 6, 14, 22, 30, 38 and 71 of 107, the page title reads: "SWEENEY CLOCK TRIANGLE AND SITE OF NEW MUSIC HALL SCHEDULE PRICING" **DELETE** "AND SITE OF NEW MUSIC HALL" from the page title.

The following questions were asked:

Question: Do the parking lots around the George R. Brown Convention Center have irrigation systems in them?

Response: There are no irrigation systems in the parking lots surrounding the George R, Brown Convention Center. Only the median in front of the George R, Brown Convention Center (where the roses are) has an irrigation system.

Question: Is landscaping required on the site of the New Music Hall now?

Response: No landscaping will be required on the site of the New Music Hall until after construction is completed. The New Music Hall will not be completed for a minimum of 3 years. If the new Music Hall is completed before this contract has expired it may be added to the contract at a mutually agreed price based on similar work in this contract.

Question: Is the path next to the Bayou behind the site of the old Music Hall to be included in the contract?

Response: Yes. The Jogging path and area between the path and the Bayou are included in the "Buffalo Bayou Schedule".

All of the preceding corrections are to be made to the revised bid document (L12374c2) which is marked **revised 7-16-99**.

Failure to use the revised bid document may be grounds for rejection of your bid.

When issued, letters of clarification shall automatically become a part of the bid document and shall supersede any previous specifications or provisions in conflict with the letters of clarification. It is the responsibility of the bidder to ensure that it has obtained all such letters. By submitting a bid on this project, bidder shall be deemed to have received all letters of clarification and to have incorporated them into its bid.
