**Honorable Mayor and City Council Members:**

The undersigned hereby proposes to furnish and deliver **fertilizers, herbicides, insecticides and non-ionic surfactant, FOB destination point as listed on the electronic bid form and on the individual Purchase Orders**, in accordance with the Net Prices and other conditions shown herein, and in accordance with the City's Specifications and General Terms and Condition Specifications. When issued, Letters of Clarification shall automatically become part of this bid document and shall supersede any previous specifications or provisions in conflict with the Letters of Clarification. It is the responsibility of the bidder to ensure that it has obtained such letters. By submitting a bid on this project, bidder shall be deemed to have received all Letters of Clarification and to have incorporated them into its bid. THE MANUFACTURER'S NAME, PRODUCT NAME AND PRODUCT NUMBER MUST BE DESIGNATED IN THE SPACE PROVIDED IF BIDDERS ARE BIDDING AN "OR EQUAL" ITEM.

The City may accept this bid offer by issuance of a Notice of Award Letter and/or a Purchase Order covering award of said bid to this Bidder at any time on or before the 120th day following the day this Official Bid Form is opened by the City. This offer shall be irrevocable for 120 days after the bid opening or for 90 days after City Council awards the bid, whichever comes last, but this period may be extended by written agreement of the parties.

The City of Houston reserves the option, after bids are opened, to increase or decrease the quantities listed, subject to the availability of funds, and/or make award by line item.

**BIDDING AND AWARD:**

It is the intent of the City to award, on the basis of overall low net bid meeting specifications for the entire award; however, the right is reserved to accept or reject in whole or in part any or all bids received and to make an award on the basis of individual item, combination of items or overall best bid, as it is deemed in the best interest of the City.

**SPECIAL BIDDERS NOTE:**

**1.0 SCOPE OF SERVICES:**

1.1 Product and Spreader Services:

- 1.1.1 Supplier shall furnish limestone and furnish/mix blended fertilizer as per City of Houston requirements based on soil samples.
- 1.1.2 Supplier shall provide all transportation, supervision, personnel, materials, insurance, Department of Transportation permits and all necessary equipment to deliver, off-load, load and spread blended fertilizer and limestone at locations designated by the City of Houston.
- 1.1.3 Spreader services shall commence immediately after delivery of product and shall be completed during the same day of delivery, subject to weather conditions. If unable to complete spreader services during the same day of delivery, supplier shall return the next working day to complete spreader services, or return as directed by the Houston Airport System (HAS) Representative. Spreader services shall be performed at these designated locations:
  - 1.1.3.1 George Bush Intercontinental Airport (approximately 1,200 acres)
  - 1.1.3.2 Ellington Field Airport (approximately 800 acres)
  - 1.1.3.3 HAS property - West (approximately 300 acres), Brookshire, Texas area
- 1.1.4 License's and Certifications, "Supplier shall have and maintain all "applicable" State of Texas and federal licenses/certifications for the sale of pesticides, insecticides and fertilizers."

1.2 Access/Control of Premises:

- 1.2.1 Access to airport premises and operation areas shall be limited to supplier's personnel and those HAS employees and/or individuals authorized by the Director or its designee and escorted by authorized City personnel. Supplier shall conform to such identification and security procedures, as the Director or its designee may deem necessary. Access to the premises shall be strictly controlled. Officers, employees or agent of the Supplier shall never enter restricted or operational areas of the Airport without the express permission of the Director or its designee or any other governmental bodies having jurisdiction, and the Supplier hereby assumes full liability arising from any such unauthorized incursions.
- 1.2.2 Security and Badging, Supplier shall comply with all applicable Federal rules governing security at the airport(s), as may be amended from time to time.
  - 1.2.2.1 All on-site personnel of Supplier, including sub-contractor's, who perform Work on the Award, are required to undergo a fingerprint-based criminal history records check. Fingerprints are collected at the airport(s) Badging Office and submitted electronically for investigation. The Project Manager shall have additional training at HAS to approve badging requests for Supplier personnel.

TECHNICAL SPECIFICATIONS FOR FERTILIZERS, HERBICIDES, INSECTICIDES AND NON-IONIC SURFACTANT FOR THE HOUSTON AIRPORT SYSTEM, CONTINUED:

**1.2 Access/Control of Premises (Continued):**

- 1.2.2.2 Supplier shall obtain HAS security badges for its personnel performing work on-site, including its sub-contractor's personnel. On-site personnel shall wear identification badges at all times while on airport(s) property. The cost of badges, which is subject to change, is currently \$61.00 each at (IAH). Costs for the fingerprint-based criminal history records check are reflected in the cost of the badges. Supplier is responsible for the cost of badges, including replacements thereof. Supplier personnel losing badges will be charged for replacement badges at the then current rate.
- 1.2.2.3 Supplier shall ensure a sufficient number of badged personnel are available at all times to perform the Work.
- 1.2.2.4 Supplier acknowledges that fines or penalties associated with non-compliance with security regulations must be reimbursed to HAS.

**1.3 Application of Chemicals:**

Type, quantity, frequency of chemicals shall be determined by the City of Houston Airport System based on crop needs.

**1.4 Material Safety Data Sheet:**

The Supplier shall provide Material Safety Data Sheets (MSDS) for every product delivered (bulk, individual container type).

**1.5 Emergency Evacuation:**

In case of an emergency while Supplier and its crew are on site, the Director or its designee may direct the Supplier to terminate all work and clear the area of equipment and/or personnel. Supplier shall comply to such an order safely and with all possible speed.

**2.0 PRICE ADJUSTMENT:**

**2.1 Producer Price Index (PPI):**

Price adjustments may be authorized based upon the latest version of the Producer Price Index (PPI), "Pesticide, fertilizer, and other agricultural chemical mfg ([http://www.bls.gov/data/home.htm\\_pcu\\_3253](http://www.bls.gov/data/home.htm_pcu_3253))" as published by the U.S. Department of Labor, Bureau of Labor Statistics.

**2.2 Price Decreases:**

Supplier shall submit a price decrease in accordance with the methodology outlined in this section at any time during the term of award that a price decrease occurs. Supplier shall immediately notify the City Purchasing Agent of price decreases in the same manner as for price increases. The price decrease shall become effective upon the 18th day of the fourth month (associated calculated month).

**2.3 Price Increases:**

2.3.1 Supplier may request a price increase in accordance with the methodology outlined in this section after approximately three (3) months from the bid opening date of the bid received by the City Secretary of the City of Houston. Subsequent price increases may be requested after approximately three (3) months from the date of the previously approved price increase.

TECHNICAL SPECIFICATIONS FOR FERTILIZERS, HERBICIDES, INSECTICIDES AND NON-IONIC SURFACTANT FOR THE HOUSTON AIRPORT SYSTEM, CONTINUED:

**2.3 Price Increases (Continued):**

2.3.2 For establishing the “Base Price – Initial Pricing” and “Subsequent Pricing”, the Supplier must submit a letter stating the amount by line item. The letter must illustrate the methodology as outlined in this section by stating the index value of base period, index value at time of calculation, base price, adjusted price, actual dollar difference, and percentage of the price increase. The letter must be sent to the address shown below. If the City Purchasing Agent approves the price increase, he or she shall notify Supplier in writing; the price increase shall become effective upon the 18th day of the fourth month (associated calculation month). **Supplier shall submit its request for increase within thirty (30) calendar days after the 18th day of the fourth month (associated calculation month) or when the final index is available. Failure to submit the request within the specified timeframe may be cause for denial of an increase for the subsequent 3-1/2 month period.**

2.3.3 If the City Purchasing Agent approves the price increase, he or she shall notify Supplier in writing; the price increase shall become effective upon the 18<sup>th</sup> day of the fourth month (associated calculation month). If the City Purchasing Agent does not approve Supplier's price increase, Supplier may terminate its performance upon sixty (60) days advance written notice to the City Purchasing Agent. Termination of performance is Supplier's only remedy if the City Purchasing Agent does not approve the price increase.

2.3.4 If, at any time after approving a price increase, the City Purchasing Agent determines that the City can obtain the same item at a lower price from a different source without violating the State bid laws, the City may then purchase the item from the lower price source without any obligation to the Supplier.

**2.4 Mechanism to re-establish pricing after bid award (Initial Pricing):**

2.4.1 The initial award pricing will be determined by adjusting the awarded bid's pricing in accordance with the documented percent of change between the monthly price index for pesticides, fertilizers, and other agricultural chemicals beginning the first month after the month bids were received by the City Secretary (Month One), i.e. February, as verified and reported by the Producer Price Index (PPI), “Pesticide, fertilizer, and other agricultural chemical mfg (<http://www.bls.gov/data/home.htm>, pcu 3253)” and the monthly price index for pesticides, fertilizers, and other agricultural chemicals from the third month after the month bids were received by the City Secretary (Month Three), i.e. April, as verified and reported by the Producer Price Index (PPI), “Pesticide, fertilizer, and other agricultural chemical mfg (<http://www.bls.gov/data/home.htm>, pcu 3253)”.

2.4.2 Note (1): The re-established pricing shall be valid until the 18th day of the fourth month. The preceding three month period (first month and third month only) will be used to calculate price increase/decrease for the next 3-1/2 month period. The first month after the month bids were received will be regarded as month number one of the first 3-month calculation period.

2.4.3 Note (2): The Council Award date will not be a factor in calculations, the percentage increase/decrease will be applied utilizing Month One and Month Three – only.

**2.5 Subsequent Price increases or Decreases**

2.5.1 Price increases and price decreases shall be evaluated/determined based on the percentage difference (increase/decrease) between the first month and third month price indexes. **Subsequent price increases/decreases shall be applied to the last adjusted price of the item(s) to be purchased.**

**2.5 Subsequent Price Increases or Decreases (Continued):**

- 2.5.2 Price increases and price decreases shall be determined by utilizing the U.S. Department of Labor, Bureau of Labor Statistics, Producer Price Index (PPI), Pesticide, fertilizer, and other agricultural chemical mfg (<http://www.bls.gov/data/home.htm>, pcu 3253), based on the percentage increase/decrease between the first-published version of the first month's index (month number one of the 3-month period) and the first-published version of the third month's index (month number three of the 3-month period). The percentage increase/decrease shall be determined on the 18th day of every fourth month or when the final index is available. However, should the contract agreement be scheduled to expire before the fourth month can be used in the calculation, the preceding months (percent change from a minimum of two months) may be used in the calculation provided the months have not already been used.
- 2.5.3 The price of the item will be re-calculated and established after the 18th day of the fourth month and will extend until the next calculation has been determined and accepted, in the following fourth month.
- 2.5.4 As stated by the Bureau of Labor Statistics (PPI), "All indexes are subject to revision four months after original publication", the City shall recognize this statement as a means to readjust up/down the calculated percentage.
- 2.5.5 Vendor to provide the City with a letter stating the requested increase, as per the U.S. Department of Labor, Bureau of Labor Statistics, after the data for the final/third month has been published. Subject to verification of data by the City of Houston. For example, see table below:

**2.6 Formula for initial pricing (re-established pricing):**

Bid Due Date (Received by City Secretary): January.  
 Month One: February, 211.4 will be used in the calculation.  
 Month Three: April, 242.3 will be used in the calculation.

Calculation to be made on the 18<sup>th</sup> day of the fourth month (or when the final index is available): May.

Bidder's original price: \$40.00  
 Formula:  $211.4 - 242.3 = 30.9 \div 211.4 = 0.146 \times 100 = 14.6\%$  increase  
 Re-established pricing (Initial Pricing) of the item will be  $\$40.00 \times 14.6 \div 100 = \$5.84$   
 $\$40.00 + \$5.84 = \$45.84$   
 Re-established pricing will be valid until August 18<sup>th</sup>.

**2.7 Formula for price adjustment (subsequent pricing) number:**

First Month: May, 257.7 will be used in the calculation.  
 Third Month: July, 307.2 will be used in the calculation.  
 Formula:  $257.7 - 307.2 = 49.5 \div 257.7 = 0.192 \times 100 = 19.2\%$  increase  
 Initial Pricing of item (see above): \$45.84  
 Subsequent Pricing:  $\$45.84 \times 19.2 \div 100 = \$8.80$ ,  $\$45.84 + \$8.80 = \$54.64$   
 New Price: \$54.64, to remain valid until November 18<sup>th</sup>.

**1.0 TERM OF AWARD:**

- 1.1 The term of the award shall be for a twelve (12) month period beginning on the date specified in the Notice of Award Letter. During this period, purchase orders will be issued for items as needed. Any conflict between the terms and conditions as specified herein and said purchase orders; the term and conditions of this award shall govern. The Supplier will not provide any goods/services without first having received an official City of Houston purchase order. While it is the intent to procure goods/services by issuing an Official City of Houston Purchase Order, there will be instances when a Purchasing Card (P-Card) or Petty Cash may be used. **The City requires that the prices bid award be honored on all purchases.**
- 1.2 It is emphasized that the City of Houston does not guarantee to purchase any specific quantity of any item listed; rather, the quantities may vary depending upon the actual needs of the user departments. Supplier shall remain obligated to the City under all clauses of this award that expressly or by their nature extend beyond and survive the expiration or termination of the award, including but not limited to warranties and indemnity provisions hereof.

**2.0 OPTIONAL EXTENSION:**

This award may be extended for one (1) additional twelve (12) month period upon acceptance of the Supplier and thirty days prior written notice from the City Purchasing Agent. A price increase subject to the provisions of this award may be requested by the Supplier for approval by the City Purchasing Agent at this time. If the price increase is approved by the City Purchasing Agent or if no price increase is requested, a letter of extension will be issued by the City Purchasing Agent for the Supplier's acceptance under the same terms and conditions as the existing award.

**3.0 SUPPLIER'S DUTY TO PAY:**

Supplier shall make timely payments to all persons and entities supplying labor, materials or equipment for the performance of this award. Supplier agrees to protect, defend, and indemnify the City from any claims or liability arising out of Supplier's failure to make such payments. (Disputes relating to payment of MWBE subcontractors shall be submitted to arbitration in the same manner as any other disputes under the MWBE subcontract. Failure of the Supplier to comply with the decisions of the arbitrator may, at the sole discretion of the City, be deemed a material breach leading to termination of this award).

**4.0 INVOICING:**

- 4.1 In order to expedite payment all invoices must be submitted in triplicate, itemized as to quantity, part number, description, and applicable discount (if any) in the same order and form as in the City of Houston Purchase Order. Variations will only delay payment. In addition, invoices must show the name of the Department, Division or Section to which the merchandise was delivered, and the City of Houston Purchase Order Number.
- 4.2 All delivery tickets must have a description of the commodity delivered.
- 4.3 Mail invoices to the Accounts Payable Section of the department and to the address, as noted on individual purchase orders.
- 4.4 Delivery tickets and packing slips shall contain the same information as the invoice.
- 4.5 All packing slips and delivery tickets must be signed by the receiving employee and must show his/her City employee number.

GENERAL TERMS AND CONDITIONS FOR FERTILIZERS, HERBICIDES, INSECTICIDES AND NON-IONIC SURFACTANT FOR THE HOUSTON AIRPORT SYSTEM, CONTINUED:

**5.0 PAYMENT:**

Payment is due thirty (30) days after the City has approved the invoice or after the City has accepted the goods, whichever occurs later.

**6.0 MATERIAL SAFETY DATA SHEETS (MSDS):**

6.1 All Bidders should submit with their bid, two (2) complete, most current copies of the required Material Safety Data Sheet (OSHA Form 174), manufacturer's safety data sheet, or such other sheet that contains the same information as the OSHA Form 174 for each product bid. Should these forms be omitted from the bid, Bidder promises to deliver said forms within seven (7) working days of receipt of notice from the City. Failure to comply with this notice will be just cause for rejection of the bid from further consideration. A Material Safety Data Sheet must accompany each shipment.

6.2 Each sheet submitted should be identified by the Bidder's complete company name; formal bid number and bid form item number.

**7.0 CONTAMINATED MATERIALS:**

Each Supplier shall be required to identify their source of supply. No material will be accepted from a hazardous or toxic waste site, regardless of whether the site has been identified by either a Local, State or Federal Agency. No contaminated, toxic, hazardous waste products or heavy metal product shall be contained in these deliveries. If any material supplied to the City is found to be contaminated or contain heavy metal products, it will be the responsibility of the Supplier to remove and replace the contaminated product at their expense and at no cost to the City. The City has the option to solicit the removal of any contaminated material and charge back the Supplier any and all costs involved.

**8.0 INSPECTIONS AND AUDITS:**

8.1 The City reserves all rights to review all payments made to Suppliers by auditing at a later date. Subject to such audit, any overpayments may be recovered from the Supplier.

8.2 Representatives of the City have the right to examine the books of all subcontractors and/or suppliers supplying goods and/or services under the prime award insofar as those books and records relate to performance under the prime award.

8.3 City representatives may have the right to perform, or have performed, (1) audits of Supplier's books and records, and (2) inspections of all places where work is undertaken in connection with this award. Supplier shall keep its books and records available for this purpose for at least three years after this award terminates. This provision does not affect the applicable statute of limitations.

**9.0 SILENCE OF SPECIFICATIONS:**

The apparent silence of these specifications as to any detail, or the apparent omission from it of a detailed description concerning any point, shall be regarded as meaning that only the best commercial practice is to prevail and that only material and workmanship of the finest quality are to be used. All interpretations of these specifications shall be made on the basis of this statement. The Bidder shall be an established Supplier of the items bid.

**10.0 SPECIFIED EQUIPMENT, OR EQUIVALENT:**

10.1 Wherever in the specifications any materials or processes are indicated or specified by patent or proprietary name and/or by name of manufacturer, such specifications shall be deemed to be used for the purpose of facilitating descriptions of the performance, materials and/or processes desired and shall be deemed to be followed by the words, "or equivalent", if not so stated in the specifications herein.

10.2 The burden of proof shall rest with the Bidder, in the course of a technical evaluation, to prove that the proposed item(s) are equivalent to the performance, materials, processes, or articles specified. **DETERMINATION AS TO WHETHER THE ITEM(S) BID IS /ARE EQUIVALENT TO THOSE SPECIFIED SHALL REST SOLELY WITH THE CITY PURCHASING AGENT AND THE RECEIVING DEPARTMENT.**

GENERAL TERMS AND CONDITIONS FOR FERTILIZERS, HERBICIDES, INSECTICIDES AND NON-IONIC SURFACTANT FOR THE HOUSTON AIRPORT SYSTEM, CONTINUED:

**11.0 DELIVERIES:**

- 11.1 The Supplier agrees to make deliveries only upon receipt of duly signed and approved Purchase Orders issued by the City of Houston City Purchasing Agent or designee. Delivery made without such Purchase Order shall be at Supplier's risk and shall leave the City the option of canceling any award implied or expressed herein.
- 11.2 Unless otherwise stated in the Bid Form or Specifications, deliveries must consist only of new and unused merchandise.
- 11.3 Full tare must be allowed and no charges made for packages.
- 11.4 In the event that the deliveries of the supplies covered in the solicitation are not made within the number of days specified, or in the event that the supplies delivered are rejected, and are not removed and replaced within the number of days specified in the official notice of rejection, the City reserves the right to terminate. The defaulting Supplier will be deemed non-responsible and will be disqualified from bidding on the solicitation if it is re-let by the City within ninety (90) days of such termination.
- 11.5 The Bidder must demonstrate its ability to secure and deliver the following products:
  - 11.5.1 Fertilizers and Limestone within three (3) working days after receipt of purchase order, subject to weather conditions at delivery site; therefore, the Bidder must be able to provide such service.
  - 11.5.2 Herbicides, Insecticides and Non-Ionic Surfactant within five (5) working days after receipt of purchase order; therefore, the Bidder must be able to provide such service.
- 11.6 Locations as stated on purchase order:
  - 11.6.1 Technical Services, 18600 Lee Rd, Houston, TX 77032 – for delivery of liquid fertilizer, herbicides, insecticides and non-ionic surfactant.
  - 11.6.2 George Bush Intercontinental Airport, Houston, TX – for delivery of fertilizers and limestone.
  - 11.6.3 Ellington Field, Houston, TX – for delivery of fertilizers and limestone.
  - 11.6.4 HAS property – West; Brookshire, TX area – for delivery of fertilizers and limestone.
- 11.7 One day in advance of the scheduled delivery, Supplier shall contact the Houston Airport System Representative for directions and to make arrangements for access to the property and an escort on the premises. Name and contact number of H.A.S. representative shall be provided after the award.

**12.0 SHIPPING TERMS:**

Prices shall be F.O.B. Destination to the delivery location designated herein or on a purchase order. The Supplier shall retain title and control of all goods until they are delivered and award of coverage has been completed. All risk of transportation and all related charges shall be the responsibility of the Supplier. The Supplier shall file all claims for visible or concealed damage. The City will notify the Supplier promptly of any damaged goods and shall assist the Supplier in arranging for inspection.

**13.0 MATERIALS:**

The items furnished shall be the latest product in production to commercial trade, and shall be of the highest quality as to materials used. The Supplier furnishing these items shall be experienced in the production of such items and shall furnish evidence of having supplied similar items, which have been in successful operation. The Bidder shall be an established Supplier of the items bid.

GENERAL TERMS AND CONDITIONS FOR FERTILIZERS, HERBICIDES, INSECTICIDES AND NON-IONIC SURFACTANT FOR THE HOUSTON AIRPORT SYSTEM, CONTINUED:

**14.0 RESTOCKING (EXCHANGES AND RETURNS):**

There will be no restocking charge to the City for return or exchange of any item purchased under the terms of this award. If the City wishes to return items purchased under this award, the Supplier agrees to exchange, these items for other items, with no additional charge incurred. Items must be returned to Supplier within thirty (30) days from date of delivery. If there is a difference in price in the items exchanged, the Supplier shall invoice the City for increase price or provide the City with a credit or cash refund for any decrease in price. On items returned, a credit or cash refund will be issued by the Supplier to the City. This return and exchange option shall extend for thirty (30) days following the expiration date of the award. All items returned by the City must be unused and in the same merchantable condition as when received. **Items that are special ordered and/or stocked by the Supplier at the specific request of the City may be returned only upon approval of the Supplier.**

**15.0 ADDITIONS & DELETIONS:**

The City, by written notice from the City Purchasing Agent to the Supplier, at any time during the term of this award, may add or delete like or similar equipment, supplies, locations and/or services to the list of equipment, supplies, locations, and/or services to be provided. Any such written notice shall take effect on the date stated in the notice from the City. Similar equipment, supplies, services, or locations added to the award shall be in accordance with the solicitation specification/scope of services, and the charges or rates for items added shall be the same as specified on the bid form. In the event additional equipment, supplies, locations and/or services are not identical to the item(s) already awarded, the charges therefore will then be the Supplier's normal and customary charges or rates for the equipment, supplies, locations and/or services classified on the bid form.

**16.0 FORCE MAJEURE**

16.1 Timely performance by both parties is essential to the award. However, neither party is liable for delays or other failures to perform its obligations to the extent the delay or failure is caused by Force Majeure. Force Majeure means fires, floods, explosions, and other acts of God, war, terrorist acts, riots, court orders, and the acts of superior governmental or military authority.

16.2 This relief is not applicable unless the affected party does the following:

16.2.1 uses due diligence to remove the Force Majeure as quickly as possible; and

16.2.2 provides the other party with prompt written notice of the cause and its anticipated effect.

16.3 The City may perform or solicit functions itself during periods of Force Majeure. Such performance does not constitute a default or breach of this award by the City.

16.4 If the Force Majeure continues for more than 30 days, the City Purchasing Agent or Director upon written authorization by the City Purchasing Agent may terminate this award by giving 30 days' written notice to Supplier. This termination is not a default or breach. SUPPLIER WAIVES ANY CLAIM IT MAY HAVE FOR FINANCIAL LOSSES OR OTHER DAMAGES RESULTING FROM THE TERMINATION EXCEPT FOR AMOUNTS DUE AT THE TIME OF THE TERMINATION.

**17.0 MEASUREMENTS:**

The measurement stated for these items are approximates. The City reserves the right to accept items that are similar in size, if in the City's judgment, the item bid fulfills the intended purpose.

GENERAL TERMS AND CONDITIONS FOR FERTILIZERS, HERBICIDES, INSECTICIDES AND NON-IONIC SURFACTANT FOR THE HOUSTON AIRPORT SYSTEM, CONTINUED:

**18.0 SAMPLES:**

- 18.1 If requested by the City, the two (2) apparent low Bidders will be required to submit samples of the items proposed within seven (7) days of such request. The samples will be used to determine if the proposed items meet the specifications stated herein.
- 18.2 **If the Bidder fails to provide samples within the seven (7) day period, as required, the City may reject your bid and not consider it for further evaluation.**
- 18.3 These samples, if not subject to destructive testing, will be returned to the supplying Supplier. A notice will be mailed to the Supplier when samples are ready to be released by the City. Supplier will have fourteen (14) days to redeem the samples. If samples are not redeemed within this time period the City cannot be responsible for condition or loss of the subject items.

**19.0 WARRANTY:**

A minimum warranty of twelve (12) months from Supplier and the manufacturer's warranty will be furnished on materials and workmanship shall be provided. The warranty period shall begin the day the City officially accepts the item. Any warranty work is to be completed within five (5) working days after receipt of item.

**20.0 RELEASE:**

PRIME SUPPLIER AGREES TO AND SHALL RELEASE THE CITY, ITS AGENTS, EMPLOYEES, OFFICERS, AND LEGAL REPRESENTATIVES (COLLECTIVELY THE "CITY") FROM ALL LIABILITY FOR INJURY, DEATH, DAMAGE, OR LOSS TO PERSONS OR PROPERTY SUSTAINED IN CONNECTION WITH OR INCIDENTAL TO PERFORMANCE UNDER THIS AGREEMENT, EVEN IF THE INJURY, DEATH, DAMAGE, OR LOSS IS CAUSED BY THE CITY'S SOLE OR CONCURRENT NEGLIGENCE AND/OR THE CITY'S STRICT PRODUCTS LIABILITY OR STRICT STATUTORY LIABILITY.

**21.0 INDEMNIFICATION:**

21.1 PRIME SUPPLIER AGREES TO AND SHALL DEFEND, INDEMNIFY, AND HOLD THE CITY, ITS AGENTS, EMPLOYEES, OFFICERS, AND LEGAL REPRESENTATIVES (COLLECTIVELY THE "CITY") HARMLESS FOR ALL CLAIMS, CAUSES OF ACTION, LIABILITIES, FINES, AND EXPENSES (INCLUDING, WITHOUT LIMITATION, ATTORNEYS' FEES, COURT COSTS, AND ALL OTHER DEFENSE COSTS AND INTEREST) FOR INJURY, DEATH, DAMAGE, OR LOSS TO PERSONS OR PROPERTY SUSTAINED IN CONNECTION WITH OR INCIDENTAL TO PERFORMANCE UNDER THIS AGREEMENT INCLUDING, WITHOUT LIMITATION, THOSE CAUSED BY:

- (1) PRIME SUPPLIER'S AND/OR ITS AGENTS', EMPLOYEES', OFFICERS', DIRECTORS', CONTRACTORS', OR SUBCONTRACTORS' (COLLECTIVELY IN NUMBERED PARAGRAPHS 1-3, "PRIME SUPPLIER") ACTUAL OR ALLEGED NEGLIGENCE OR INTENTIONAL ACTS OR OMISSIONS;
- (2) THE CITY'S AND PRIME SUPPLIER'S ACTUAL OR ALLEGED CONCURRENT NEGLIGENCE, WHETHER PRIME SUPPLIER IS IMMUNE FROM LIABILITY OR NOT; AND
- (3) THE CITY'S AND PRIME SUPPLIER'S ACTUAL OR ALLEGED STRICT PRODUCTS LIABILITY OR STRICT STATUTORY LIABILITY, WHETHER PRIME SUPPLIER IS IMMUNE FROM LIABILITY OR NOT.

GENERAL TERMS AND CONDITIONS FOR FERTILIZERS, HERBICIDES, INSECTICIDES AND NON-IONIC SURFACTANT FOR THE HOUSTON AIRPORT SYSTEM, CONTINUED:

**21.0 INDEMNIFICATION (CONTINUED):**

21.2 PRIME SUPPLIER SHALL DEFEND, INDEMNIFY, AND HOLD THE CITY HARMLESS DURING THE TERM OF THIS AGREEMENT AND FOR FOUR YEARS AFTER THE AGREEMENT TERMINATES. PRIME SUPPLIER'S INDEMNIFICATION IS LIMITED TO \$500,000 PER OCCURRENCE. PRIME SUPPLIER SHALL NOT INDEMNIFY THE CITY FOR THE CITY'S SOLE NEGLIGENCE.

21.3 INDEMNIFICATION PROCEDURES:

(1) Notice of Claims. If the City or Prime Supplier receives notice of any claim or circumstances which could give rise to an indemnified loss, the receiving party shall give written notice to the other party within 10 days. The notice must include the following:

- (a) a description of the indemnification event in reasonable detail,
- (b) the basis on which indemnification may be due, and
- (c) the anticipated amount of the indemnified loss.

This notice does not estop or prevent the City from later asserting a different basis for indemnification or a different amount of indemnified loss than that indicated in the initial notice. If the City does not provide this notice within the 10 day period, it does not waive any right to indemnification except to the extent that Prime Supplier is prejudiced, suffers loss, or incurs expense because of the delay.

(2) Defense of Claims

- (a) Assumption of Defense. Prime Supplier may assume the defense of the claim at its own expense with counsel chosen by it that is reasonably satisfactory to the City. Prime Supplier shall then control the defense and any negotiations to settle the claim. Within 10 days after receiving written notice of the indemnification request, Prime Supplier must advise the City as to whether or not it will defend the claim. If Prime Supplier does not assume the defense, the City shall assume and control the defense, and all defense expenses constitute an indemnification loss.
- (b) Continued Participation. If Prime Supplier elects to defend the claim, the City may retain separate counsel to participate in (but not control) the defense and to participate in (but not control) any settlement negotiations. Prime Supplier may settle the claim without the consent or agreement of the City, unless it (i) would result in injunctive relief or other equitable remedies or otherwise require the City to comply with restrictions or limitations that adversely affect the City, (ii) would require the City to pay amounts that Supplier does not fund in full, (iii) would not result in the City's full and complete release from all liability to the plaintiffs or claimants who are parties to or otherwise bound by the settlement.

**22.0 WORKER'S COMPENSATION INSURANCE:**

On any City award with a labor component or any award where Supplier delivery people make deliveries for City sites, Worker's Compensation Insurance as shown in the Insurance Section is required.

GENERAL TERMS AND CONDITIONS FOR FERTILIZERS, HERBICIDES, INSECTICIDES AND NON-IONIC SURFACTANT FOR THE HOUSTON AIRPORT SYSTEM, CONTINUED:

**23.0 INSURANCE:**

- 23.1 If performance of this award requires Supplier to provide labor in addition to supplies, labor and materials, the Supplier shall have insurance coverage and furnish certificates of insurance showing the City as an additional insured, in duplicate form, prior to the beginning of the award. The City shall be named as an additional insured on all such policies except Worker's Compensation. **The issuer of any policy shall have a Certificate of Authority to transact insurance business in the State of Texas or have a Best's rating of at least B+ and a Best's Financial Size Category of Class VI or better, according to the most current edition of Best's Key Rating Guide, Property-Casualty United States.** Comprehensive General Liability including Contractual Liability, Automobile Liability and Pollution Liability insurance shall be in at least the following amounts: Automobile Liability Insurance for autos furnished or used in the course of performance of this award including Owned, Non-owned, and Hired Auto coverage (Any Auto coverage may be substituted for Owned, Non-owned and Hired Auto coverage.) If no autos are owned by Supplier, coverage may be limited to Non-owned and Hired Autos. If Owned Auto coverage cannot be purchased by Supplier, Scheduled Auto coverage may be substituted for Owned Auto coverage. EACH AUTO USED IN PERFORMANCE OF THIS AWARD MUST BE COVERED IN THE LIMITS SPECIFIED - \$1,000,000.00 Combined Single Limit.
- 23.2 \$1,000,000.00 per occurrence; \$2,000,000.00 aggregate, per 12-month policy period. Worker's Compensation including Broad Form All States endorsement shall be in statutory amount.
- 23.3 All insurance policies required by this award shall require on their face, or by endorsement, that the insurance carrier waive any rights of subrogation against the City, and that it shall give thirty (30) days written notice to the City before they may be cancelled. Within such thirty (30) day period Supplier, covenants that it will provide other suitable policies in lieu of those about to be cancelled so as to maintain in effect the coverage required under the provisions hereof. Failure or refusal of the Supplier to obtain and keep in force the above-required insurance coverage shall authorize the City, at its option, to terminate this award at once.
- 23.4 ONLY UNALTERED ORIGINAL INSURANCE CERTIFICATES, EXCLUDING ANY ALTERATION AND INITIALS REGARDING CANCELLATION WHICH IS MADE TO MEET CITY REQUIREMENTS, AS ENDORSED BY THE UNDERWRITER ARE ACCEPTABLE. PHOTOCOPIES ARE UNACCEPTABLE.

**24.0 SUCCESSORS AND ASSIGNMENTS:**

Supplier may not assign this award or dispose of substantially all of its assets without the written consent of the City Purchasing Agent. Supplier's failure to obtain such consent shall be an event of default, authorizing the Purchasing Agent to terminate this award according to its terms.

**25.0 MINORITY AND WOMEN BUSINESS ENTERPRISES:**

- 25.1 These provisions apply to goal-oriented contracts. A goal oriented contract means any contract awarded for the supply of goods or non-professional services of approximately \$100,000.00 for which competitive bids are required by law and which the City Purchasing Agent has determined to have City of Houston Certified MWBE subcontracting potential.
- 25.2 Prime Supplier agrees to comply with the City's Minority and Women Business Enterprise programs as set out in Chapter 15, Article V of the City of Houston Code of Ordinances insofar as such programs apply to this Contract. Prime Supplier further agrees that it will make good faith efforts to award subcontracts or supply agreements in at least **8%** of the value of this Contract to Minority and Women-owned Business Enterprises certified by the City's Affirmative Action Division. In addition, Prime Supplier acknowledges that it has reviewed the requirements for good faith efforts that are on file with the City's Affirmative Action Division, is familiar with such requirements, and will comply with them.
- 25.3 Prime Supplier shall require written subcontracts with all MWBE subcontractors and suppliers, which must contain the terms, set out in the documents attached herein. If Prime Supplier is an individual person (as distinguished from a corporation, partnership, or other legal entity), and the amount of the subcontract is \$50,000 or less, then the subcontract must also be signed by the attorneys of the respective parties.
- 25.4 Refer to the "City of Houston Goal-Oriented Minority and Women Business Enterprises Contract Provisions" attachment, which is incorporated in the specifications herein by this reference for all purposes, for more detailed information on this requirement.

GENERAL TERMS AND CONDITIONS FOR FERTILIZERS, HERBICIDES, INSECTICIDES AND NON-IONIC SURFACTANT FOR THE HOUSTON AIRPORT SYSTEM, CONTINUED:

**26.0 TAXES:**

The City is exempt from the Federal Excise and Transportation Tax, and the limited Sales and Use Tax. Unless the Bid Form or Specifications specifically indicate otherwise, the price bid must be net exclusive of above-mentioned taxes, and will be so construed. A Supplier desiring refunds of, or exemptions from, taxes paid on merchandise accepted by the City, must submit the proper forms, and the City Purchasing Agent, if satisfied as to the facts, will approve or issue the necessary certificates.

**27.0 AWARD:**

27.1 The City reserves the right to consider and make awards of bids on articles of similar nature that will in all respects serve the purpose for which the purchase is being made. The City reserves the right to be the sole judge as to whether such articles will serve the purpose.

27.2 Unless otherwise specified, the City reserves the right to accept or reject in whole or in part any bid submitted or to waive any informality for the best interest of the City.

**28.0 REJECTIONS:**

28.1 Articles not in accordance with samples and specifications must be removed by the Supplier and at his expense. All disputes concerning quality of supplies delivered under this invitation to bid will be determined by the City Purchasing Agent or designated representative.

28.2 All articles enumerated in the invitation to bid shall be subject to inspection on delivery by an officer designated for the purpose and if found inferior to the quality called for, or not equal in value to the Department's samples, or deficient in weight, measurements, workmanship or otherwise, this fact shall be certified to the City Purchasing Agent who shall have the right to reject the whole or any part of the same.

**29.0 BRAND NAME:**

Any manufacturer's names, trade names, brand names, or catalog numbers used in the specifications are for the purpose of describing and establishing the general quality level, design and performance desired. Such references are not intended to limit or restrict bidding by other Suppliers, but are intended to approximate the quality design or performance, which is desired. Any bid, which proposes like quality, design or performance, will be considered. Equivalent products will be considered, provided a complete description and product literature is provided. Unless a specific exception is made, assumption will be that the item is bid exactly as specified on the Invitation to Bid.

**30.0 CHANGE ORDER:**

30.1 At any time during the term of the award, the City Purchasing Agent or Director upon written authorization by the City Purchasing Agent may issue a Change Order to increase or decrease the scope of services or change plans and specifications, as he or she may find necessary to accomplish the general purposes of this award. The Supplier shall furnish the services or deliverables in the Change Order in accordance with the requirements of this award plus any special provisions, specifications, or special instructions issued to execute the extra work.

30.2 The City Purchasing Agent or Director upon written authorization by the City Purchasing Agent will issue the Change Order in substantially the following form:

**30.0 CHANGE ORDER (CONTINUED):**

- 30.3 The City Purchasing Agent or Director upon written authorization by the City Purchasing Agent may issue more than one Change Order, subject to the following limitations:
- 30.3.1 Council expressly authorizes the City Purchasing Agent or Director upon written authorization by the City Purchasing Agent, to approve a Change Order of up to \$25,000. A Change Order of more than \$25,000 over the approved awarded amount must be approved by the City Council.
  - 30.3.2 If a Change Order describes items that Supplier is otherwise required to provide under this award, the City is not obligated to pay any additional money to Supplier.
  - 30.3.3 The total of all Change Orders issued under this section may not increase the original award amount by more than 25%.
- 30.4 Whenever the Supplier receives a Change Order, Supplier shall furnish all material, equipment, and personnel necessary to perform the work described in the Change Order. Supplier shall complete the work within the time prescribed. If no time for completion is prescribed, Supplier shall complete the work within a reasonable time. If the work described in any Change Order causes an unavoidable delay in any other work Supplier is required to perform, Supplier may request a time extension for the completion of the work. The City Purchasing Agent's or Director's decision regarding a time extension is final.
- 30.5 A product or service provided under a Change Order is subject to inspection, acceptance, or rejection in the same manner as the work described in the original award and is subject to the terms and conditions of the original award as if it had originally been a part of the award.

**31.0 TERMINATION OF AWARD:**

31.1 By the City for Convenience:

The City Purchasing Agent may terminate this award at any time upon 30-calendar days notice in writing to the Supplier. Upon receipt of such notice, Supplier shall, unless the notice directs otherwise, discontinue all services in connection with the performance of the award and shall proceed to cancel promptly all existing orders and awards insofar as such orders and awards are chargeable to this award. As soon as practicable after the receipt of notice of termination, the Supplier shall submit a statement to the appropriate department(s) showing in detail the services performed or items delivered under this award to date of termination. The City agrees to compensate the Supplier for that portion of the prescribed charges for which the services were actually performed or items delivered and not previously paid.

31.2 By the City for Default by Supplier:

31.2.1 In the event that the materials and/or services furnished by the Supplier do not conform to the standard set forth herein, or if the deliveries and servicing of this award do not conform to the requirements detailed herein, the City through a written notice from the Purchasing Agent to the Supplier describing such default may as its options:

(a) Terminate the award for default and the City shall have no further obligation.

(b) Allow the Supplier to cure default within a reasonable time as specified in the notice. The City, at its sole option, may extend the proposed date of termination to a later date. If prior to the proposed date of termination, Supplier cures such default to the City's satisfaction, then the proposed termination shall be ineffective. If Supplier fails to cure such default prior to the proposed date of termination, then the City may terminate its performance as of such date and have no further obligation under the award.

31.2.2 In the event of failure to deliver any or all of the items or to perform required services, the City may cover its loss by reasonably procuring from another source the items not delivered or the services not performed. Supplier shall be responsible for and shall pay to the City immediately upon demand the difference in price between that offered by the Supplier and that which the City was forced to pay for covering Supplier's failure to deliver or perform services.

GENERAL TERMS AND CONDITIONS FOR FERTILIZERS, HERBICIDES, INSECTICIDES AND NON-IONIC SURFACTANT FOR THE HOUSTON AIRPORT SYSTEM, CONTINUED:

**31.0 TERMINATION OF AWARD (CONTINUED):**

31.3 By the Supplier for Default by City:

- 31.3.1 Default by the City shall occur if the City fails to perform or observe the terms and conditions of the award required to be performed or observed by the City, and the Supplier gives notice in writing to the City within 30 calendar days of the act or omission claimed by the Supplier to constitute default on the part of the City.
- 31.3.2 Upon receipt of such notice in writing from the Supplier, however, the City shall have 30 calendar days to cure such default. The Supplier, at its sole option, may extend the proposed date of termination to a later date.
- 31.3.3 If City cures such default prior to the proposed date of termination, the proposed termination shall be ineffective. If the City fails to cure such default prior to the proposed date of termination, then the Supplier may terminate its performance as of such date.

**32.0 PATENTS:**

The Supplier agrees to indemnify and save harmless the City, the City Purchasing Agent and assistants from all suits and actions of every nature and description brought against them or any of them, for or on account of the use of patented appliances, products or processes, and he shall pay all royalties and charges which are legal and equitable. Evidence of such payment or satisfaction shall be submitted, upon request of the City Purchasing Agent, as a necessary requirement in connection with the final estimate for payment in which such patented appliance, products or processes are used.

**33.0 SUPPLIER DEBT**

If Supplier, at any time during the term of this award, incurs a debt, as the word is defined in section 15-122 of the Houston City code of ordinances, it shall immediately notify the City Controller in writing. If the City Controller becomes aware that Supplier has incurred a debt, she shall immediately notify Supplier in writing. If Supplier does not pay the debt within 30 days of either such notification, the City Controller may deduct funds in an amount equal to the debt from any payments owed to Supplier under this award, and Supplier waives any recourse therefore.
