To All Prospective Bidders:

This Letter of Clarification is issued for the following reasons:

- To revise the above referenced solicitation as follows:

1) In Section B, page 6 of 16, Item 1.1 **change**: "JFG to MFG"; Item 1.3.2 **change** "9.76 to **97.6**," and Item: 1.3.3.1.2 **change** "3.8V to **13.8V**."

To answer the following question:

1. *Question*: "We have noticed that the Batteries, Gelled Electrolyte Cell bid for Public Works has no DBE goals. Why are there no goals?"

Answer: "The Office of Business Opportunity (OBO) carefully reviewed and evaluated the 0% goal request. During the review and evaluation, it was found that the batteries will be drop shipped directly from the manufacturer to the City of Houston's warehouse. Consequently, the only work that was able to be identified as divisible was transportation. However, after conferring with the Contract Compliance Division, it was determined that the transportation component would be very negligible on this particular solicitation. Therefore, based on the recommendation received and the negligible identified divisible component (transportation), a 0% MWBE Participation Goal was approved."

2. *Question*: "Please send me: 1) The current contract price for the batteries. 2) The list of registered bidders."

Answer: 1) "The current prices may be obtained by visiting the <https://purchasing.houstontx.gov> website and using the drop down feature, click online purchasing catalog, enter batteries in Keyword Search and select Gel Cell."

2) "The Buyer Vendor List is attached."



Furthermore, it is the responsibility of each Supplier to obtain any previous Letter(s) of Clarification associated with this solicitation.




