**THIS FIRST AMENDMENT TO AN AGREEMENT FOR INFORMATION SYSTEM SUPPORT CONSULTING SERVICES** (the "First Amendment") is made by and between the **CITY OF HOUSTON, TEXAS** (the "City"), a municipal corporation and home-rule city of the State of Texas, principally situated in Harris County, Texas, acting by and through its governing body, the City Council, and **JEFFERSON ASSOCIATES, INC.** (the "Contractor"), a corporation doing business in the State of Texas.

**WITNESSETH**

**WHEREAS**, pursuant to Ordinance No. 2001-1072 the City entered into an Agreement for information system support consulting services (the "Original Agreement") (FC53335) with Contractor; and

**WHEREAS**, the parties desire to amend the Original Agreement to extend the term for one additional one-year period; and

**NOW, THEREFORE**, the City and Contractor amend the Original Agreement as follows:

**I**

The parties hereby agree to amend Section B, Renewals, of Article V, Term and Termination, to the Original Agreement by revising Section B to read as follows:

If the Director, at his or her sole discretion, makes a written request for renewal to Contractor at least 30 days before expiration of the then-current term and if sufficient funds are allocated, then, upon expiration of the initial term, this Agreement is renewed for five (5) successive one-year terms upon the same terms and conditions.

II

In the event of a conflict between the Original Agreement and this First Amendment, this First Amendment shall prevail.

III

All other terms and conditions of the Original Agreement, except as amended in this First Amendment, shall continue in full force and effect.
