| Description: | Plastic donation box permit decal (sample attached). <u>This decal shall be of a reflective nature with a high destructible ability.</u> |
| Quantity: | 500 |
| Size: | See attached sample – 5 x 7. Die-Cut Design. |
| Color | Black ink on bright yellow background; number in black on bright white background |
| Numbers: | Consecutively numbered (0001-0500) |
| Packaging: | Individual stickers in bundles of 200. |
| Delivery: | On or before <u>June 30, 2023.</u> |
| Decals: | Used for the exterior of donation boxes. Decal must remain on the donation box in inclement weather. Decal must have City of Houston Seal located as placed in the attached sample. Printing is only on one side of the decal. |
| Material: | The decals shall be manufactured from destructible sheeting. The addition of a reflective water-mark to give it anti-counterfeit properties is preferred. |
| Adhesive: | The adhesive on the back of the decals shall be of a special formulated pressure sensitive adhesive which requires no water, solvent or other wetting agent for activation. The adhesive shall be of permanent type as not to be affected by heat or cold. The adhesive bond shall remain permanent for a period of one year after application. |
| Inks: | Sun resistant ink that will remain legible for a period of one year after application shall be used on all printing and design work on the face of the decals. |
| Destructibility: | The decals must withstand tests of destructibility after application. The decals shall attain such a tight bond to the surface that it will remain affixed until it is intentionally or manually removed. If an attempt is made to remove the decal from the application surface, it shall be destroyed through tearing or distortion. |

| Color | Black ink on bright yellow background; number in black on bright white background |
| Numbers: | Consecutively numbered (0001-4,000) |
| Packaging: | Individual stickers. Bundles of 200. |
| Delivery: | On or before <u>June 30, 2023.</u> |
| Decals: | Used for the front interior windshield on all vehicles for hire. Printing is on front and back of decal. Adhesive should be on front of decal for placement on the front interior windshield of vehicle. Decal must have City of Houston Seal located as placed in the attached sample. |
| Material: | The decals shall be manufactured from acetate destructible sheeting. |
| Adhesive: | The adhesive on the front of the decals shall be of a special formulated pressure sensitive adhesive which requires no water, solvent or other wetting agent for activation. The adhesive shall be of permanent type as not to be affected by heat or cold. The adhesive bond shall remain permanent for a period of one year after application. |
| Inks: | Sun resistant ink that will remain legible for a period of one year after application shall be used on all printing and design work on the face of the decals. |
| Destructibility: | The decals must withstand tests of destructibility after application. | Packaging: | Individual stickers in bundles of 200. |
| Delivery: | On or before <u>June 30, 2023</u>. |
| Decals: | Used for the rear exterior window on taxicab vehicles and on the seat post of pedicabs. Decal must remain on the vehicle in inclement weather. Decal must have City of Houston Seal located as placed in the attached sample. Printing is only on one side of the decal. |
| Material: | The decals shall be manufactured from destructible sheeting. The addition of a reflective water-mark to give it anti-counterfeit properties is preferred. |
