This Letter of Clarification is issued for the following reasons:

• **To revise the above referenced solicitation as follows:**

1. Page 16, Section 14.0 – Airport Customs Security Area Bond of the “SPECIFICATIONS/SCOPE OF WORK,” has been deleted in its entirety.

14.0 AIRPORT CUSTOMS SECURITY AREA BOND

~~14.1 Contractor shall obtain an Airport Customs Security Area Bond in order to have access to the Federal Inspection Station (FIS) located at George Bush Intercontinental Airport (IAH).
