TO: All Prospective Respondents

This Letter of Clarification is issued for the following reasons:

- **To provide clarity to questions number 1 and 15 issued in Letter of Clarification No. 2:**

1. Question What does PCS stand for?
Answer Portable Computer Systems (PCS)

15. Question Is the city expecting a full removal of all components of the competitive system, specifically cables that are hidden by seats, interior panels, prisoner cages, and those protruding through the roof? If so, will the city hold the removing entity harmless with no liability for any damage to other equipment in the vehicle? If not, would it be acceptable to cut any wires prior to entry into the cab or roof so no other components are disturbed and leave the hidden portions in their current place. It would be more prudent, more cost effective and less risky for the City's fleet management to do the competitive removal - would the city be open to a credit by the vendor to perform this via the city as an alternative?

Answer Yes, the vendor will be responsible for removing all components & wiring of the current system installed.

When issued, Letter(s) of Clarification shall automatically become a part of the solicitation documents and shall supersede any previous specification(s) and/or provision(s) in conflict with the Letter(s) of Clarification. By submitting a proposal on this project, respondents shall be deemed to have received all Letter(s) of Clarification and to have incorporated them into their proposals.
